- Responding units may **NOT** exceed the total number of primary units in each category
 - Exception Division 9 (Chicago) – If needed, deploy remaining required EMS units from NE section if SE section has been depleted
- On an Interdivisional request of (2) or less units, the units will report directly to the assigned staging area of the incident.
- On Interdivisional request where (3) or more units are requested, if a Chief is not requested SEECOM / MCSO shall automatically assign a Chief to respond. Units will report to an assigned staging area as determined by the responding Chief.
- On Strike Team requests, units will report to an assigned staging area as determined by the responding Chief.
- Departments are to notify MABAS Dispatch Center if responding or if alternate units will be needed within 15 minutes.
- These requests are NOT dispatched on IFFER
